Why we should all vote for Los Angeles County Measure W by Scott Houston — Director, West Basin Municipal Water District Division 4

As West Basin Division #4 Water Board Director, my job is to make sure that when you turn on the tap, your water is safe, clean, and affordable. Our Water Board today must respond to the effects of global climate change, which has caused changes in precipitation patterns. (Did you know that even in Sweden they are having a problem with over-pumping of groundwater?)

Measure W prepares us for the new normal of extreme heat and more frequent droughts. It will create the Safe, Clean Water Program in L.A. County

that funds projects and programs to capture, clean and conserve storm water. This, in turn, increases our local water supply, improves water quality, and creates opportunities for new recreational green space and habitat.

Each year more than 100 billion gallons of rainwater, carrying a multitude of pollutants and contaminants, flows through our storm drains and into the ocean. Measure W will help capture and use this precious water source while also protecting public health and reducing contaminants that find their

way into our groundwater and the sea. Keeping pollutants from hitting our storm drains falls on local governments with no dedicated funding source to meet their obligations. The 88 cities and unincorporated areas of L.A. County routinely violate federal and state laws governing toxic pollutants and the environment, and these cities and the County will soon be hit with fines. Measure W provides that funding. Vote Yes on Measure W.

California State Senator Holly Mitchell and Assemblymember Sydney Kamlager-Dove endorse Culver City schools' Measure K

Flat parcel tax will be on November 6 ballot

California State Senator Holly Mitchell and Assemblymember Sydney Kamlager-Dove (District 54) both endorsed Culver City Schools' Measure K this past weekend. Measure K is an upcoming ballot measure that will place an annual flat parcel tax of \$189 per year on all residential and commercial private properties in Culver City, raising approximately \$2,362,500 annually. One hundred percent of this money will be funneled directly into Culver City Schools.

The Culver City Unified School District (CCUSD) Board of Education voted unanimously to place this measure on the November 6 ballot in order to bridge the gap between money that the District receives from the state, and the impending shortfall that will result from mandated increases in public employee retirement programs.

"The State of California passed a law requiring school districts to pay more for employee retirement programs," explains CCUSD School Board President Anne Allaire. "Complying with this law will cost our school district over two million dollars every year. Getting this

parcel tax passed is a vital component of our school district's future financial health. If it doesn't pass, we will be forced to make some drastic cuts to our core academic programs and will not be able to keep pace with median teacher salaries."

According to the language on the ballot, Measure K will be used to:

- Maintain and improve core academic programs like science, technology, engineering, math (STEM); English and writing;
- Fund vocational education programs, preparing students for college and modern careers;
- Help retain and attract high quality teachers and staff (including counselors, nurses and aides) to educate and support our students;
- Maintain small class sizes;
- Support and grow Culver City's robust arts curriculum and competitive

athletics;

- Ensure that students with special needs are included with their general education peers in all PK-12 classrooms;
- Bolster urgently needed social and emotional support for Culver City students;
- Enhance district-wide safety measures.

"I have proudly represented Culver City as part of the 30th State Senate for 8 years, and am proud to endorse Measure K," says California Senator Holly Mitchell. "This parcel tax will provide resources and funds to ensure that all students will continue to thrive. Vote YES for Measure K on November 6!"

Measure K mandates an independent oversight committee to ensure funds are spent as promised. These funds cannot be spent on administrators' salaries.

aries, benefits or pensions. Seniors and people with disabilities will be offered an exemption from paying the parcel tax.

“Well-educated children help our communities thrive, and great schools keep our neighborhoods strong and prosperous and safeguard property values,” adds Allaire. “Excellent public schools, which depend upon public support, are the foundation of a vibrant residential and business community. Measure K is a wise investment that will protect Culver City schools. We hope everyone who goes to the polls on November 6 will vote yes on Measure K – it’s for our kids.”

Measure K requires a two-thirds majority to pass. Should it pass, it will begin July 1, 2019 for the next seven years. During this time, the Measure is expected to raise approximately \$16,537,500.

In addition to Senator Mitchell and Assemblymember Kamlager-Dove, early endorsers of Measure K include the following organizations: Culver City Federation of Teachers (CCFT), Culver City Association of Classified Employees (CCACE), Management Association of Culver City Schools (MACCS), Culver City Education Foundation (CCEF), Community Budget Advisory Committee (CBAC), Culver City Council of PTAs, Culver City Democratic Club, Fineshriber Family Foundation, and The Culver Studios. In addition, all five school board members (President Anne Allaire, Vice President Dr. Kelly Kent, Clerk Kathy Paspalis, and Governing Members Dr. Steve Levin and Summer McBride) endorse Measure K, as does CCUSD Superintendent Leslie Lockhart.

Measures C and D on the Culver City ballot

On November 6, Culver City voters will decide two important questions specific to the City of Culver City.

Measure C asks whether Culver City should collect an additional quarter cent sales tax (\$0.25 per \$100 of taxable sales) to maintain current city service levels. Whether it's 911 response times, senior services, or maintaining parks, playgrounds, sports fields, and the city pool, Culver City delivers diverse, high-quality amenities to residents. As demands on our general fund grow and our daytime population surges, however, we need to plan for the future so that we can remain a first-class, full-service city. A yes vote on Measure C will help finance that future.

Measure D asks Culver City voters whether we should move our city council elections (currently held in April) to coincide with statewide general elections (held in November).

Turnout in off-cycle April elections is notoriously abysmal. For example, our most recent city council election in April had higher turnout than any local election in recent memory, but only 7,473 people voted, out of about 27,000 registered voters. This is about 28 percent. In 2014, just 14 percent of voters cast ballots. In contrast, participation in the last four statewide general elections has exceeded 67 percent. In fact, in November 2016, 70 percent of Culver City voters made it all the way to the end of a historically long ballot to vote on a Culver City measure. That means that more than four times as many people voted on a local ballot measure in 2016 than voted for city council in 2014!

Democracy works best when all voices are heard, and general elections attract younger voters, less affluent voters, and voters of color. Our city government will be much more effective and fair if it is accountable to these voters.
