

Propositions on the California ballot November 6

Prop. 1 – Veterans and Affordable Housing Bonds

This would authorize issuance of bonds in the amount of four billion dollars. Three billion dollars of the proceeds would be used to finance various existing housing programs as well as infill infrastructure financing and affordable housing matching grant programs. The remaining billion dollars would be used to provide assistance in the purchasing of homes for veterans. *[Editor's note: Proposition 1 is endorsed by the California League of Cities.]*

Prop. 2 – No Place Like Home Act of 2018

This would specify that the service contracts between the California Health Facilities Financing Authority and the Department of Housing and Community Development may be single-year or multiyear contracts and it would provide for payments to the department from amounts on deposit in the Supportive Housing Program Subaccount. In addition, it would include any appropriation or transfer to the No Place Like Home Fund from the General Fund or other funds as moneys required to be paid into the No Place Like Home Fund. The bill would authorize the Legislature to amend the No Place Like Home Act of 2018 by a two-thirds vote, so long as the amendment is consistent with and furthers the intent of the act. *[Editor's note: Proposition 2 is endorsed by the California League of Cities.]*

Prop. 3 – Water Supply and Water Quality Act of 2018

This authorizes bonds to fund projects for water supply and quality, watershed, fish, wildlife, water conveyance and groundwater sustainability and storage. The initiative authorizes \$3.03 billion for safe drinking water and water quality; \$2.895 billion for watershed and fisheries improvements; \$940 million for habitat protection; \$855 million for improved water conveyance; \$685 million for groundwater sustainability and storage; and \$472 million for surface water storage and dam repairs. *[Editor's note: Proposition 3 is endorsed by the California League of Cities.]*

Prop. 4 – The Children's Hospital Bond Act Of 2018

This authorizes \$1.5 billion in bonds, to be repaid from the state's General Fund, to fund grants for construction, expansion, renovation and equipping of qualifying hospitals providing children's health care. *[Editor's note: Proposition 4 is endorsed by the California Democratic Party.]*

Prop. 5 – Property Tax Transfer Initiative

This would amend Proposition 13 (1978) to allow homebuyers who are age 55 or older or severely disabled to transfer the tax-assessed value from their prior home to their new home, no matter (a) the new home's market value; (b) the new home's location in the state; or (c) the number of moves. If the new home is a different value than the prior home, the initiative would allow for an adjusted value between the old and new values. If the new home has a higher market value than the prior home, the assessed value would be adjusted upward. If the new home has a lower market value than the prior home, the assessed value would be adjusted downward. *[Editor's note: Proposition 5 is endorsed by the California Association of Realtors and the California Chamber of Commerce. It is opposed by the*

California Teachers Association and Rep. David Chiu. It has been called another tax giveaway to the wealthy.]

Prop. 6 – Gas Tax Repeal Initiative

This would repeal a 2017 transportation law's tax and fee revisions that pay for repairs and improvements to local roads, state highways, and public transportation. It will lower transportation tax revenues in the future by requiring voter approval of such tax increases, with the impact dependent on future actions by the Legislature and voters. *[Editor's note: Proposition 6 is endorsed by most Republicans in California. It is opposed by a coalition of just about everybody else.]*

Prop. 7 – Permanent Daylight Saving Time Measure

This would allow the California State Legislature to establish permanent, year-round daylight saving time in California by a two-thirds vote if federal law is changed to allow for permanent daylight saving time.

Prop. 8 – Limits on Dialysis Clinics' Revenue

This limits amounts outpatient kidney dialysis clinics may charge for patient care and imposes penalties for excessive charges. It requires annual reporting to the state regarding clinic costs, patient charges and revenue. It prohibits clinics from discriminating against patients based on the source of payment for care. *[Editor's note: Proposition 8 is endorsed by SEIU. It is opposed by the two largest for-profit companies that do kidney dialysis.]*

Prop. 9 – WILL NOT APPEAR ON THE BALLOT

This proposition would have broken California into three states. It was removed from the ballot by the California Supreme Court.

Prop. 10 – Local Rent Control Initiative

This repeals the Costa-Hawkins Rental Housing Act, which currently restricts the scope of rent control policies that cities and other local jurisdictions may impose. *[Editor's note: Proposition 10 is endorsed by the California Democratic Party and opposed by the California Republican Party.]*

Prop. 11 – Ambulance Employees Paid On-Call Breaks

This requires private-sector emergency ambulance employees to remain on call during work breaks. It also makes the labor law that entitles hourly employees to take meal and rest breaks without being on call inapplicable to private-sector emergency ambulance employees. It exempts employers from potential liability for violations of existing law regarding work breaks. *[Editor's note: Proposition 11 is opposed by the California Teachers Association]*

Prop. 12 – Farm Animal Confinement Initiative

This establishes new standards for confinement of certain farm animals and bans the sale of certain non-complying products. It requires egg-laying hens to be raised in a cage-free environment after December 31, 2021. It establishes new minimum space requirements for confining veal calves, breeding pigs and egg-laying hens. It prohibits sales of specified meat and egg products from animals confined in a non-complying manner. *[Editor's note: Proposition 12 is supported by the Humane Society of the United States.]*

Club endorses two bills to help protect the environment

There are two bills in the California Senate that will help the environment if they become law. They are SB 100, authored by Kevin De Leon, and SB 834, co-authored by Hannah-Beth Jackson and Ricardo Lara. The Culver City Democratic Club has endorsed both bills.

SB 100 establishes the 100 Percent Clean Energy Act of 2017, which increases the Renewables Portfolio Standard (RPS) requirement from 50 percent by 2030 to 60 percent. It also creates the policy of planning to meet all of the state's retail electricity supply with a mix of RPS-eligible and zero-carbon resources by December 31, 2045, for a total of 100 percent clean energy.

It's our belief that California needs to lead the way in fighting climate change. 100 percent renewable is possible in the time frame set out in SB 100. This bill would be a bold step forward.

SB 834 Prohibits the State Lands Commission (SLC) or a local trustee from entering into any new lease or entering into any lease renewal, extension, or modification authorizing new construction of oil-and-gas-related infrastructure upon tidelands and submerged lands within state waters associated with Outer Continental Shelf (OCS) leases issued after January 1, 2018.

The Trump administration's proposal to drill offshore is dangerous and short sighted. We would like to see passage of SB 834 as the beginning of the end of all oil drilling, including fracking, across California.
